Legal League 100 members have expert knowledge in mortgage default law and frequently comment on issues of local and national concern.

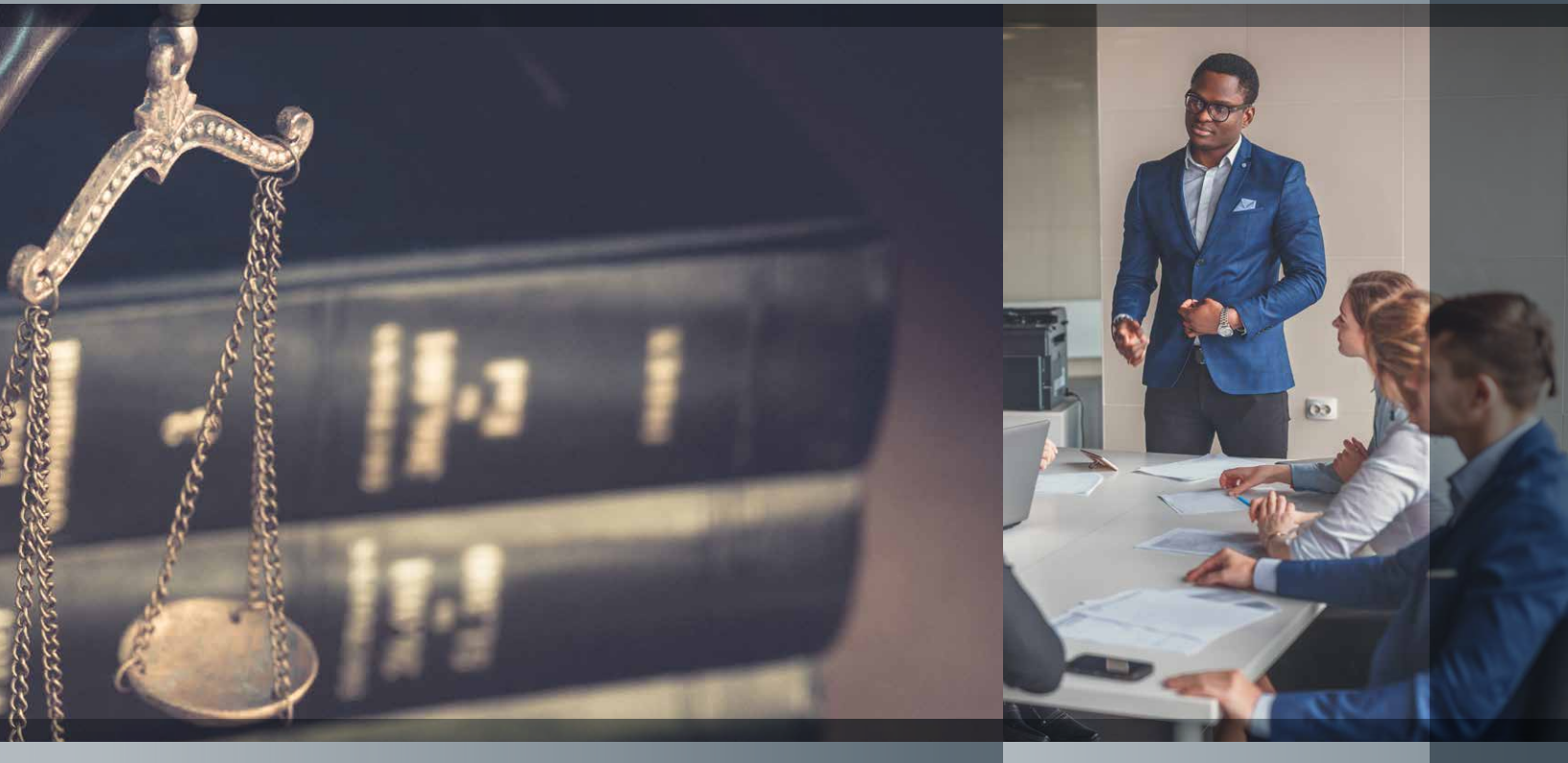
### EXPANSIVE REACH AND INFLUENCE

# Sphere of Focus

The heart of the Legal League 100 is in providing an opportunity for the membership to directly shape the industry that they serve. The Legal League 100 subcommittee focuses on affecting change concerning the most pressing issues impacting financial services firms. Positions on each of the subcommittees are open to the membership at-large.



Legal League 100's Special Initiatives Working Group (SIWG) responds to a shift in the industry that now requires law firms to operate at a more efficient level. The SIWG consists of senior representation from member firms and associate members, all working together to focus on strategic objectives of concern to financial services legal professionals, as directed by the Legal League 100 Advisory Council. The group's objectives center around three primary areas:

## EDUCATION

The Legal League 100 hosts two summits each year (one each spring and one each fall, alongside the Five Star Conference). These summits cover hot topics, and invite conversations relevant to attendees effecting the default mortgage industry. Members have the opportunity to host and attend educational webinars covering mortgage default law issues as well as certification courses appropriate for either professionals new to the industry or seasoned legal minds (through Five Star Academy).

## ADVOCACY

Coordinating the production of letters to government agencies to effect change, amicus briefs, position papers, and other materials created to influence the judiciary and public policy on critical issues pertaining to mortgage servicing and legal practice.

## SERVICER RELATIONS

The production of materials and communications with the servicing community that focus on process improvements and best practices in law firm oversight.
